The Organization is also developing a proprietary backpack that they will distribute as part of this program. The Organization intends to employ veterans in the assembly of these backpacks so that veterans can gain employable skills and a work history.

The Organization has developed an online resource portal, ROGER, where veterans and their families can search for resources in their area. As part of this program, The Organization gets directly involved with some of the most at risk veterans.
